POLICY STATEMENT:

The purpose of this policy is to provide a fee structure for the Wainwright & District Communiplex.

PROCEDURES:

That effective May 16th, 2012 the fees be as follows:

MEETING ROOMS \$10.82 + GST/hour/room to a maximum of \$17.95/hour

MAIN HALLS & 6:00am – 2:00am \$24.86 + GST / hour / hall

FITNESS STUDIO 2:00am – 4:00am \$74.59 + GST / hour / hall

THEATRE (seats extended & using theatre lights)

6:00am – 2:00am \$31.74 + GST / hour

2:00am – 4:00am \$95.23 + GST / hour

THEATRE (leaving sets in place for week leading up to performance)

All day \$81.11 + GST / day

3-HALL RENTAL 6:00am – 2:00am \$63.35 + GST / hour

2:00am – 4:00am \$186.42 + GST / hour

KITCHEN \$17.95 + GST / hour to a maximum of \$179.45 +GST / day
Coffee urns and drip coffee maker are provided with rental of the kitchen and are not to be removed from the facility.

CONCESSION \$64.87 + GST / day

WALK-IN COOLER \$48.31 + GST / day
(When not renting kitchen)

BACK STAGE / WORKSHOP AREA

Workshop area behind the Theatre is not included in rehearsal time and is available free of charge to local performing groups for property construction. This space must be kept clean and tidy at all times in respect of other user groups.

REHEARSALS

Without theatre lighting

\$24.86 + GST flat rate for first 3 hours

With theatre lighting

\$31.74 + GST flat rate for first 3 hours

** Regular hourly hall rate applies after first 3 hours of rehearsal time.

Theatre lighting (anytime)

\$6.90 + GST / hour

The Communiplex will be closed between 4am and 6am daily.

DISCOUNTS

For bookings of two or more consecutive days (a day being defined as eight (8) consecutive hours of booking each day) the fees for the second and subsequent days will be ten percent (10%) less.

SCHOOL BOOKINGS

In order to use town facilities, all local schools agree to pay a fee which is calculated as 20-percent of the existing youth rate (where applicable). Access to the Communiplex pool, kitchen and use of theatre lighting are not covered by this fee. Where a youth rate is not available, the schools agree to pay 20-percent of the general public rate for each location. Set-up for activities provided under this policy must be carried out during the normal hours that the facility is staffed. Set-up time outside of these hours will be charged for based on youth rental rates. Bookings made and then not used by schools will be subject to regular rental rates, and schools will be considered a "regular weekly renter" under our cancellation policy, unless the reservation involves a large special event (i.e. graduation or conference).

WEIGHT ROOM \$9.24 + GST / hour
(School access as maximum group of 10)

COURTS \$3.36 + GST / hour
(School access)

CANCELLATIONS – ALL FACILITIES

Regular Weekly Bookings - cancellations must be received at least forty-eight (48) hours in advance of the scheduled booking. Notification of cancellations within forty-eight (48) hours of the booking will be subject to payment of the full cost of the booking.

All Other Bookings (non-weekly reservations or stand-alone event bookings ~ i.e. tournaments, half/full day and/or multi-day events, etc.):

1. A cancellation fee (20%) of the total booking fee or \$15.00 ~ the greater of the two) will apply to all cancellations received a minimum of fourteen (14) days in advance of the booking.
2. Cancellation notification between thirteen (13) days and 48-hours of the booking, the renter will pay 50% of the full booking fee as agreed in the contract.
3. Cancellation notification less than 48-hours prior to the booking, or renters that are "no-shows" at the time of their event, will be required to make full payment for the booking fee as agreed in the contract.

All cancellations due to poor local weather conditions must be communicated with the Communiplex pool staff (or custodian on duty) at least one-hour prior to the commencement of the booking. If this occurs, and the staff person agrees with the weather assessment, the renting group will not be subject to financial penalty. The final determination on whether or not this levy is applied will be made at the sole discretion of the Director of Parks and Recreation. When requested, all efforts will be made to reschedule the facility time at a later date.
