POLICY STATEMENT:

The purpose of this policy is to provide a fee structure for the Wainwright & District Communiplex Swimming Pool.

PROCEDURES:

That effective September 1st, 2016 the fees are as follows and all prices include GST unless otherwise indicated:

COURT RENTALS

Wallyball \$16.75

ADMISSIONS RATIONALE

The basis of single admissions for Junior and Senior passes for the Communiplex Swimming Pool, Courts and Gym are based on 80% of the adult rate, rounded to the nearest \$.25. Child rate is based on a rate of 50% of the Jr./Sr. rate, rounded to the nearest \$.25. The family rate is based on the anticipated cost of two adult and one child admissions.

Annual passes are equivalent to the cost of three quarterly passes. Quarterly passes are the equivalent of 23 visits over the three months. Monthly passes are the equivalent to the cost of ten single admissions, and will allow unlimited individual access for a full month period. The strip ticket bundles (10-pack of single admission tickets) are the equivalent of "buy nine – receive the tenth free," with the advantage that these tickets never expire.

All admissions include use of the swimming pool, gym, and courts per visit.

CANCELLATIONS – ALL FACILITIES

Regular Weekly Bookings - cancellations must be received at least forty-eight (48) hours in advance of the scheduled booking. Notification of cancellations within forty-eight (48) hours of the booking will be subject to payment of the full cost of the booking.

All Other Bookings (non-weekly reservations or stand-alone event bookings ~ i.e. tournaments, half/full day and/or multi-day events, etc.):

1. A cancellation fee (20%) of the total booking fee or \$15.00 ~ the greater of the two) will apply to all cancellations received a minimum of fourteen (14) days in advance of the booking.
2. Cancellation notification between thirteen (13) days and 48-hours of the booking, the renter will pay 50% of the full booking fee as agreed in the contract.
3. Cancellation notification less than 48-hours prior to the booking, or renters that are "no-shows" at the time of their event, will be required to make full payment for the booking fee as agreed in the contract.

All cancellations due to poor local weather conditions must be communicated with the Communiplex pool staff (or custodian on duty) at least one-hour prior to the commencement of the booking. If this occurs, and the staff person agrees with the weather assessment, the renting group will not be subject to financial penalty. The final determination on whether or not this levy is applied will be made at the sole discretion of the Director of Parks and Recreation. When requested, all efforts will be made to reschedule the facility time at a later date.
